

FULL, FINAL AND UNCONDITIONAL RELEASE OF LIABILITY AND PARTICIPATION AGREEMENT FOR THE Y.O. RANCH ADVENTURE CAMP, INC.

I have knowingly and willingly entered into a Y.O. Ranch Adventure Camp, Inc. ("Camp") activity and agree to abide by all Camp rules, terms, provisions and conditions. I understand that if any member of my or my child's party displays unsafe, unethical, illegal, or disruptive actions or disobeys rules/policies, the entire party may be removed from the activity at the sole discretion of Camp personnel, whom have absolute authority over every activity. In the event that any photographs, slides, interviews or video tapes are made of myself or any minor child of mine, I consent to the release of those images for further use by the Camp.

IN CONSIDERATION FOR THE RIGHT TO PARTICIPATE IN THE Y.O. RANCH ADVENTURE CAMP, INC., I UNCONDITIONALLY RELEASE, INDEMNIFY AND HOLD HARMLESS THE Y.O. RANCH ADVENTURE CAMP, INC., **Y O RANCH PARTNERSHIP AND ESTATE OF CHAS. SCHREINER, III, DECEASED, ESTATE OF LOUIS A. SCHREINER, II, DECEASED, CHAS. SCHREINER, IV, WALTER R. SCHREINER, JR. AND GUS L. SCHREINER**, THE OWNERS OF THE RANCH, THEIR SPOUSES, AGENTS, EMPLOYEES, HEIRS, EXECUTORS, ADMINISTRATORS, SUCCESSORS AND ASSIGNS, JOINTLY AND SEVERALLY (COLLECTIVELY "RELEASEES") FROM AND AGAINST ANY AND ALL CLAIMS, DEMANDS, CAUSES OF ACTION OR RIGHTS OF ACTION, AND DAMAGES, INCLUDING ATTORNEY FEES, FOR INJURY, DEATH, ILLNESS, DISEASE, OR PROPERTY DAMAGES WHICH ARE THE RESULT OF, RELATED TO, ARISE OUT OF, OR ARE IN ANY WAY CONNECTED WITH THE PARTICIPATION OF MYSELF OR MY CHILD IN ANY ACTIVITY OF THE CAMP, TO INCLUDE BUT NOT LIMITED TO **ANY NEGLIGENT ACTS OR OMISSIONS OF RELEASEES, IT BEING SPECIFICALLY INTENDED AND AGREED TO RELEASE RELEASEES FROM THEIR OWN NEGLIGENCE. THIS RELEASE IS INTENDED, AND SHALL BE CONSTRUED, TO EXCLUDE AND RELEASE RELEASEES FROM ANY AND ALL LIABILITY.**

Should it become necessary for any RELEASEE named herein to incur attorney's fees and costs to enforce this agreement, or any portion thereof, or because of my failure to abide by its terms, I agree to pay said RELEASEE'S reasonable costs and attorney's fees thereby expended, or for which liability is incurred.

I further acknowledge and understand that no warranty, either expressed or implied, is made by the Camp as to (1) any Camp activity, or (2) any roads, buildings, gates or other improvements upon which a Camp activity shall take place. I further acknowledge and understand that Camp activities may involve dangerous conditions, risks and hazards, including but not limited to, poisonous snakes, insects and spiders; elevated structures such as blinds, tree stands, ropes courses, cliffs, and other elevated structures creating risks and dangers of falling; erosive, un-level and/or rough conditions of the ground creating hazardous and generally dangerous driving, walking and/or riding conditions; animals, both wild and domesticated, that may be diseased and/or potentially dangerous; deep water creating risks of drowning; use of firearms and knives creating risk of accidental injuries; and the use of vehicles and the risks of accidental injuries associated therewith. I am aware of these, and all other, conditions and expressly assume all dangers, risks and hazards.

I give permission to have emergency first-aid administered to myself or my child in the sole discretion of Camp employees, and give permission for myself or my child to be transported by the most expedient means of conveyance to the nearest physician, hospital, or clinic and to there received such treatment as is medically prescribed by a physician. I certify that I, and/or any child of mine, have no past or present physical or mental condition that might affect my (or my child's) participation in any Camp activity, and to my knowledge, I (or my child) am/is fully capable of participating in the activity without causing harm to myself (my child) or others.

I understand and agree that this Full, Final and Unconditional Release of Liability and Participation Agreement for the Y.O. Ranch Adventure Camp, Inc. is governed by the laws of the State of Texas, and is enforceable in Kerr County, Texas.
